

AFTON VILLAGE SWIM CLUB POOL PARTIES

Reserve the Afton Village Swim Club (AVSC) Pavilion

AVSC members in good standing are eligible to reserve the pool pavilion for semi-private parties, based on availability. AVSC is a great place for birthday or graduation parties, BBQs, or simply a summer gathering of friends.

All events are based on 2 hours and a maximum of 40 guests. Guest count must include anyone attending the event whether they will swim or not.

The fee to reserve the pavilion is \$100 for events ending by 2 p.m.; the fee for events beginning at or after 2 p.m. is \$150. A refundable cleaning deposit of \$50 is also required and will be returned after assessment of the cleaning of the pavilion and pool area. All checks should be made payable to AVSC.

Parties must be scheduled during regular operating hours. No more than 2 parties, 1 in the afternoon and 1 in the evening, will be scheduled per day. Guests will share pool facilities and grounds with other patrons; however, the pavilion and covered grill will be reserved for your exclusive use.

Clean up of the pavilion and pool area is the responsibility of the party host.

Policies for Pool Parties at SVC

1. Safety Rules – The party host agrees to all pool safety rules and will sign an agreement so stating which must be returned with the pool party contract. General safety rules will be enforced at all times. Lifeguards are in charge throughout the entire event. Lifeguards are on-site to insure the safety of all swimmers, in the water and out. All policies and rules set forth by AVSC will be adhered to at all times. In addition, water balloons are not allowed in any area of AVSC.
2. Payment Policy – The reservation fee (\$100 for events ending by 2 p.m.; \$150 for events beginning at or after 2 p.m.) is due upon booking of the event. **The reservation fee is non-refundable.** In addition, a \$50 cleaning deposit is due along with the reservation fee. The cleaning deposit (\$50) is refundable after final assessment of the cleaning of the party area. A completed pool party contract must accompany your payment and deposit. Please make checks payable to AVSC. There will be a \$25 fee for returned checks.
3. Reservation Policy – Pool parties are based on a first-come, first-served basis. To reserve a date, a completed and signed party rental contract must accompany the reservation fee for your event. Due to insurance regulations, we require that all guests attending an event, including parents or other non-swimmers, be included in your total count of guests.
4. Alcohol – Alcoholic beverages are permitted at the pool by those allowed to consume alcoholic beverages by law (over the age of 21); however, no glass is allowed on pool grounds. Intoxicated individuals will be asked to leave immediately. **As per AVSC by-laws, consumption of alcoholic beverages must be discreet and in moderation.**

5. Pre-Party Set Up – You will be allowed 30 minutes for set up and clean up before and after your event. The lifeguard may be available during that time to assist you, safety conditions in the pool permitting.
